General notes

About the European Union (Consumer Information, ■■■■■■■■■■■■■■■■■■ 2013

For a marketplace business, the Regulations are as confusing as ■■■■■■■■■■■■■■■■■■ ■■ .

The operation of a market place website involves three contracts: between you and the buyer; between you and the seller; and between the buyer and the seller. To keep it simple, the first two are not subject to the ■■■■■■■■■■■■■■■■■■ ■■■■■■■■■■■■■■■■■■ ■■■■■■■■■■■■■■■■■■ .

Your contract with the seller, as in this document, is beyond the scope of the Regulations. However, you are the agent of the seller. Your agency may cover several activities, or it may be limited to taking money or customer information. The Regulations do state clearly that you are liable to comply in your capacity as an agent. Therefore, we recommend that the best way by far, to avoid the pitfalls of the Regulations is to remove yourself from the line of fire. - d. the arrangements for payment and supply of service;
- e. the telephone cost of communicating with the seller when it is not calculated ■■■■■■■■■■■■■■■■■■ ;

- f. the existence of your customer's right to cancel the contract; and the conditions, time limit ■■;
- g. whether, if the customer exercises the right to cancel, he must pay money to your ■■;
- h. the circumstances under which the customer loses the ■■ .

If the buyer at any time chooses to purchase a service from your website, he may cancel his order within 14 days without giving any reason. When he cancels the order, your seller must give him his money back within 14 days after receiving the cancellation order. But there is a way out. If the customer instructs your seller/supplier to start his work before the 14 day period expires, and provided he has warned the customer that he will lose his right to cancel, then the ■■ - ■■ . ■■ . ■■ .
